## **Covid Business From Society**

After December 1, 2022, all prior requirements, including social distancing, masking, vaccinations, & testing under the COVIDsafe policy shall be lifted, including those previously left to the Kingdoms to determine, except that the following language is still required to appear on all event notices, flyers, online announcements, & advertisements, as well as being posted in multiple locations (including gate) at any & all SCA-sponsored functions going forward:

Although the SCA complies with all applicable laws to ensure the health & safety of our event participants, we cannot eliminate the risk of exposure to infectious diseases during in-person events. By participating in the in-person events of the SCA, you acknowledge & accept the potential risks. You agree to take any additional steps to protect your own health & safety & those under your control as you believe to be necessary.

Participants who have tested positive at any time in the ten days preceding their intended entrance to an SCA event should not attend any SCA event.

The Board recommends that anyone experiencing symptoms consistent with COVID or who has been exposed to COVID within the five days preceding an event, should self-test the morning of their intended arrival at an event.

Anyone experiencing symptoms consistent with COVID at an SCA event should leave the event immediately.
